

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.hvwatersports.com, and Waves On The Bay LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Waves On The Bay LLC include www.hvwatersports.com, Hudson Valley Watersports, Hudson Valley Watersports, hudsonvalleywatersports.com and wavesonthebay.com. The Hudson Valley Watersports website is a Boat Charter and Watersports site. By using the Hudson Valley Watersports website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, Hudson Valley Watersports may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number
- Date of Birth

If you purchase Hudson Valley Watersports's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

Hudson Valley Watersports may also collect anonymous demographic information, which is not unique to you, such as your:

- Age
- Gender

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. These may include: (a) registering for an account; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services. We also may gather additional personal or non-personal information in the future.

Use of your Personal Information

Hudson Valley Watersports collects and uses your personal information to operate and deliver the services you have requested.

Sharing Information with Third Parties

Hudson Valley Watersports does not sell, rent or lease its customer lists to third parties.

Hudson Valley Watersports may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is transferred to the third party.
